
### **Roles and Responsibilities of Anti Ragging Committee:**


- This committee's primary responsibility is to continuously monitor ragging and, in the event of an incident, to take appropriate legal action as prescribed under **The Uttar Pradesh Prohibition of Ragging in Educational Institutions Act, 2010** and Curbing the Menace of Ragging in Higher Educational Institutions by UGC [No. F. 1-127/2011 (Anti Ragging)].
- In order to accomplish the goal, it is mandatory for students to give their consent in form of an affidavit along with their parents as annually as long as they are studying in the institute against the ragging practices in and outside the campus and this affidavit will be handled by ARC members or administrative office.
- Hostellers will give additional affidavit stating that they will not be take part in any ragging related activity and misconduct.
- In addition to this the committee members will constantly monitor all the concern areas of the campus throughout the academic calendar to nullify any incident.
- CCTV cameras and signs boards with student helpline numbers have been built and put up in all the main areas to prevent and spread awareness against the ragging.
- For more vigilance and oversee the performance, an Anti Ragging Squad comprising of students will be formed by ARC.

If any such incident happens, students can contact any committee members at any time. The contact numbers of Anti-Ragging Committee members is readily available:

- According to the guidelines, a victim of ragging at campus has to register the complain with ARC, and in the case of a string of episodes, three months from the date of the final incidence to make a written complaint must be produced.
- The complainant's name and address must be legible, and the complaint must never be anonymous. The complaint must be specific about its nature and include dates and locations.
- The victim's relative, friend, coworker and any other person with knowledge of the incident, with the victim's written consent, may file a complaint in accordance with the **Uttar Pradesh Prohibition of Ragging in Educational Institutions Act, 2010 and Curbing the Menace of Ragging in Higher Educational Institutions by UGC [No. F. 1-127/2011 (Anti Ragging)]** and one should give the written complaint to any ARC member.

\*The institute and its hostel are ragging free as per the directives of honorable Supreme Court 2009 judgement. A committee comprising of faculty members, senior students and staff ensure that no incident of ragging happens in and outside the campus. The institute ensures to create a healthy, learning relationship between juniors and seniors.
