Scope of work

The primary objective of this MOU is to establish a collaborative arrangement whereby the first party agrees to provide Outpatient Department (OPD) and Inpatient Department (IPD), Pathology and Radiology services to the students and employees of the second party.

- OPD Consultation Discount: A 50% discount on OPD consultation, resulting in a coordinate IQAC reduced charge of Rs 200 per consultation.

- Bed Charges Discount: A 25% discount on inpatient bed charges.
- Free General Ward Accommodation: General ward accommodation is provided free of charge to Students.
- Diagnostic Services Discount: A 25% discount on in-house laboratory and radiology investigations.
- Discounted Health Checkups: 25% discount on complete health checkups for eligible students and employees of the Second Party.
- **Discounted Medicine** 10% discount on Medicine for students.

- Cashless Services for Eligible UP Govt Employees and Their Dependent or TPA
 (Health Insurance) Card Holder: Eligible employees of the Uttar Pradesh
 Government and their dependent, as identified by the relevant authorities, shall have
 access to cashless healthcare services provided by First Party. Cashless Services for
 Eligible Aayushmaan Bharat Card holder and Other Insurance Company (TPA)'s
 shall have access to get treatment.
- Credit Facility: Credit facility is available, subject to obtaining written approval from
 the Registrar or Vice-Chancellor. Bill of the same will be shared with the authorities
 via mail at the time of discharge.

Terms and Conditions:

- Identification Requirement: Recipients must present valid identification like Student / Employee ID card of College /University to avail the specified discounts.
- Credit Facility Approval: The credit facility is contingent upon approval by the Registrar or Vice-Chancellor of college and adherence to the agreed terms.
- Promotion and Communication: Both parties agree to collaborate in promoting and communicating the benefits outlined in this MOU through appropriate channels.

Date of Effect

This AGREEMENT will come into effect on the date of signature/last date of previous MoU whichever is later and will remain in force for **three year** until either side delivers a prior written notification to the other of its intention to terminate the agreement in which case it will terminate two month after the receipt of such a notification. The agreement can be renewed on expiry on mutually agreed terms and conditions.

Dispute Resolution:

Any dispute arising out of this agreement shall be referred to a mutually acceptable arbitrator in Lucknow, and the award shall be acceptable to both parties.

Modifications

The AGREEMENT may be amended by mutual consent through an exchange of correspondence between the two Parties.
