INTERNAL COMPLAINTS COMMITTEE (ICC) POLICY

"The truth will set you free," is the motto of the Techno Institute of Higher Studies (TIHS). We at TIHS believe that regardless of a person's caste, creed, socioeconomic rank, or gender, the values of justice, humanism, and dignity should be applied. An Internal Complaints Committee (ICC) for TIHS to consider complaints of sexual harassment of staff and students will be established in accordance with the institution's ethos, the directives of the National Commission for Women, and the Hon'ble Supreme Court Judgment on the subject of sexual harassment of women in the workplace. These are details on the Act, the rules, and the duties of the ICC as prescribed in HANDBOOK on Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013. Complaints regarding Sexual Harassment must be made in written (Clear handwriting) or typed on paper with sign and date of complainant.

- According to the Act, a person who has experienced sexual harassment at work has three months from the date of the incident to file a written complaint, and in the case of a series of incidents, three months from the date of the last incident. The nature of the complaint must be clearly stated in detail, along with dates and locations.
- The complainant's name and address must be legible and the complaint must never be anonymous.
- In accordance with the <u>Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Rules, 2013</u>, a complaint may be filed, among other things, by the victim's relative, friend and coworker, officer of the National Commission for Women or State Women's Commission, or any other person who has knowledge of the incident, with the victim's written consent.
- One should give the written complaint to any internal ICC member.
