Amendment:

Any amendment to this MoU shall be made in writing and signed by both parties.

Governing Laws accordingly:

- Resolution of Dispute: If there are any disagreements about the terms of this MoU or the operation of programmes authorized by this MoU, both parties are agreeing to refrain from unilateral action. Any relevant action will be taken through consultation with each other by the concern authority appointed by both parties.
- Funding: This MoU will not impose any financial obligations for the two parties.
 Whenever necessary, separate approvals will be obtained from relevant authorities independent of this MoU.
- ➤ Termination: Either party may terminate this MoU by providing a minimum of one month's written notice to the other party. The termination of this MoU will not affect any activity or project that is subject to a further agreement between the parties, unless the relevant agreement provides otherwise.
